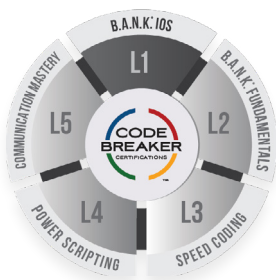

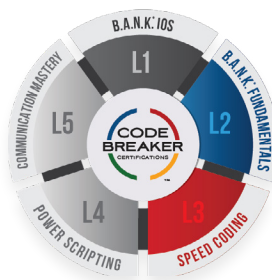

OPTION 1: BANK IOS CERTIFICATION



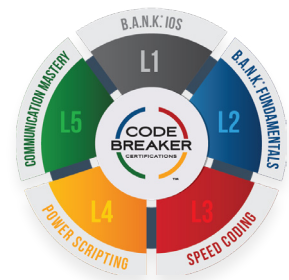

CODEBREAKER SMALL BUSINESS, LLC PRODUCT PURCHASE TERMS & CONDITIONS CANCELLATION & REFUND POLICY | RIGHT OF RESCISSION

CANCELLATION & REFUND POLICY: I hereby acknowledge that on today's date, I purchased from Codebreaker Small Business, LLC (AKA "Codebreaker SB" for short), one or more of their products as indicated on the front side of this form. This purchase has a three (3) calendar day Right of Rescission. The rescission expiration date is noted on the front side of this form; however, if left blank, I understand the last day to cancel shall be calculated as shown in the next paragraph.

The 3-calendar day period begins at midnight (Pacific Time) on the first day (the day of my signature) and goes until midnight (Pacific Time) of the third full day thereafter. For example, if I purchase on a Monday, then my last day to cancel would be on Thursday at 11:59 PM Pacific Time. All days – including holidays – are considered a calendar day.

IMPORTANT: To cancel during the 3-day rescission period for this purchase and to receive a refund, I understand that I must send an email notification to support@codebreakertech.com requesting my desire to cancel this transaction and to request a refund of monies paid. After 3 days, absolutely no refunds will be honored or processed. Furthermore, I agree to the following:

- If the 3-day rescission period has expired, I may no longer rescind this purchase.
- If the 3-day rescission period will expire and I am not in attendance at the purchased event, I acknowledge the rescission period will be 3 days.
- If the rescission period will expire during an included event from my purchase and I am in attendance at said event, I acknowledge the 3-day cancellation period will be forfeited and no refunds will be given for any of my purchases once checked in to that event.
- If I purchased at an event on the day of (as a walk-up) and attend said event that same day, I acknowledge the 3-day cancellation period will be forfeited and no refunds will be given for any of my purchases once checked in to that event.

These notices are effective when published. I agree to check my email and VO on a regular basis. I understand Codebreaker SB Policies, Prices and Program Content are subject to change with little or no notice.

DISPUTES: I am entering into a contract with Codebreaker Small Business, LLC in Clark County, Nevada. I agree that the Courts in Clark County, Nevada have the exclusive jurisdiction and are the exclusive venue to adjudicate any dispute regarding the interpretation or enforcement of this Contract. If any provision of this Contract is contrary to law, it will not void the Contract as a whole. Any such violating provisions will be stricken, and the remainder of the Contract shall remain in full force and effect.

EVENT REGISTRATION: Event tickets are non-transferable between individuals. If I need assistance in choosing or changing my event registration dates/location, I will send an email to support@codebreakertech.com requesting assistance. If I need to change my event registration, I must make this request within thirty (30) days prior to the start of the registered event.

ATTENDANCE: My Certification ticket is valid for one person (me) and I understand I must attend the Certification events within one (1) year from the date of purchase. If I choose Option 3, I understand I will have a second (2nd) year from date of purchase to attend L3 and L4 Certification. Certification courses are offered both in virtual/online format as well as live/in-person format (the B.A.N.K. IOS Certification (AKA "Coach Certification") is offered online only). Either option is valid for my Certification. Failure to attend the course or failure of completing the course during my purchase term will result in forfeiture of my purchase and my ticket will no longer be valid. Exceptions may be honored by Codebreaker SB on a rare basis for extenuating circumstances. If needed, I will email support@codebreakertech.com to request an extension beyond the 1-year period; however, I acknowledge that my ticket expires after 1-year (for Coach, L1, or L2) and Codebreaker SB reserves the right to deny my extension request.

EVENT ACCOMMODATIONS: Coach Certification is online only. But Trainer Certification is sometimes offered online or at live events. Course/Ticket pricing includes event tuition only. All food and related travel expenses are NOT included in the course price. Full payment for the course must be received prior to attending the first Certification event. Trainers who have not completed payment for their course will not be granted admission, unless otherwise authorized by Codebreaker SB in writing.
